Johnson Controls is pleased to offer the following pricing for the above-mentioned project based on the following scope of work:

Boiler pricing:

- Shutdown, LOTO, disconnect, remove and dispose of two existing boilers, boiler pumps, building pumps and accessories
- Provide engineering and stamped drawings for boiler room to account for installation of new boilers, piping and pumps
- Supply and install two new 530 MBH Viessmann Vitoden natural gas boilers, boiler pumps, building pumps, one 79-gallon sidearm heat exchanger and necessary accessories
- All equipment to be replaced into existing locations
- Supply and install necessary piping to reconnect boilers, side arm heat exchanger, boiler pumps and building pumps into the existing hot water piping system
- Supply and install new boiler flue and condensate piping with necessary hangers, supports and strapping
- Supply and install necessary insulation for hot water piping
- · Reconnect necessary electrical to the newly installed hot water equipment
- Provide test and balancing of the hot water system
- Shutdown, disconnect, remove and dispose of exiting BAS controllers related to the hot water system
- Supply, install and program new BAS controllers into existing panels that are related to the hot water system with updated engineered control drawings

Chiller pricing:

- Shutdown, LOTO, disconnect, remove and dispose of existing Trane air cooled chiller on roof, remote
 evaporator in the basement and two chilled water pumps
- Supply and install one 80-ton York air cooled packaged chiller on roof with necessary accessories
- Supply and install two 20 hp chilled water pumps
- Supply and install new chilled water piping from the chilled water pumps in the basement up to the York chiller, through the newly available chase in place of the old boiler ductwork
- Provide engineering and stamped drawings for resizing chilled water pumps to account for additional dynamic head due to additional chilled water piping from the basement to the roof
- York air cooled packaged chiller to be mounted in same location of existing Trane chiller
- Provide test and balancing of the chilled water system
- · Reconnect necessary electrical to the newly installed chilled water equipment
- Shutdown, disconnect, remove and dispose of exiting BAS controllers related to the chilled water system
- Supply, install and program new BAS controllers into existing panels that are related to the chilled water system with updated engineered control drawings

Jail rooftop unit pricing:

- Shutdown, LOTO, disconnect, remove and dispose of existing AAON RTU on the roof
- Supply and install one AAON packaged RTU with necessary accessories (like-for-like replacement)
 - o Unit to be 100% outdoor air, DX cooling and natural gas heat
 - New RTU has a different footprint, which will require the new RTU to be mounted on an adaptor curb
- Supply and install new natural gas and condensate piping to the unit
- Reconnect supply duct work to newly installed RTU
- Reconnect necessary electrical to the newly installed RTU
- Shutdown, disconnect, remove and dispose of exiting BAS controllers related to the Jail RTU
- Supply, install and program new BAS controllers into existing panels that are related to the Jail RTU with updated engineered control drawings

Clarifications:

- Pricing is based on the boilers being replaced first, so that room for the new chilled water piping up to the roof is available through the existing boiler flue chase
- Pricing is based on all work being performed during Monday-Friday, 8 AM 6 PM
- Assume use of building parking, restrooms, and general facilities
- Adherence to Johnson Controls safety standards
- Final installation schedule will be determined once equipment is ordered and the lead time is verified
- Cheyenne County to assist with scheduled shutdowns of systems and coordination of timing of work

Exclusions:

- Any temporary cooling, heating or power for the execution of this work or during the execution of this work is excluded
- Any upgrades or modifications to the existing electrical service
- Any asbestos testing or abatement
- Any additional engineering or engineered drawings other than the ones mentioned above
- Any interior or exterior painting
- Any labor or materials not specifically addressed in the above scope of work
